

Liberty Ragdolls Kitten Purchase Contract

The following agreement is made between Liberty Ragdolls (hereafter referred to as the Seller) and _____ (hereafter referred to as "Purchaser" for the sale and purchase of one purebred cat of the Ragdoll breed.

The total amount paid for the kitten is Two thousand dollars (\$2000.00), of which Two hundred dollars (\$200.00) is a non-refundable deposit.

Balance of Purchase Price to be paid in Cash at the time of kitten pick up.

The Seller transfers in fee all the responsibilities, privileges, and rights associated with owning a cat of the Ragdoll breed to the Purchaser as of the date specified below. This represents the entire agreement between the Seller and the Purchaser in an Outright sale.

HEALTH:

The Seller guarantees the kitten to be in a healthy condition and is free from any illness at the time of sale.

The Purchaser agrees to quarantine the kitten from all household pets for a period of thirty (30) days to avoid transmission of any illness or bacteria.

The Purchaser agrees to have a complete physical examination by a veterinarian of their choice within three (3) business days of receiving the kitten. The Seller agrees to guarantee the kitten against any life-threatening congenital defect, and if the veterinarian should find a defect, a certificate signed by a licensed veterinarian should be presented to the Seller within 48 hours, and a replacement kitten from the next available litter, of the same quality, will be offered to the Purchaser.

If the kitten should expire during the first year of life, the Seller agrees to provide a replacement kitten only if the Purchaser provides to the Seller an autopsy report by a licensed veterinarian to determine the cause to be congenital/hereditary. No cash refunds will be offered.

The Purchaser acknowledges that Fiv/Felv and FIP are not considered genetic defects, and it is the sole responsibility of the Purchaser to follow good quarantine practices to avoid contraction of these diseases.

The Purchaser acknowledges that failure to complete a physical evaluation within the three (3) day period upon receipt of the kitten will void the 1-year health against congenital/hereditary disease guarantee and any replacement options.

The Purchaser agrees to provide routine veterinary healthcare for the kitten for the duration of its life.

CARE:

The Purchaser agrees that the kitten shall remain indoors at all times and will not be allowed to roam freely outside. Ragdolls are very docile and not able to defend themselves against natural predators.

The Purchaser agrees to not declaw the kitten at any period of its life.

The Purchaser agrees to provide the kitten with adequate food and water for the duration of its life.

RELINQUISHMENT OF OWNERSHIP:

The Purchaser agrees that if at any time the Purchaser wants to place the kitten in another home, they will consult with the Seller about its placement. Liberty Ragdolls may be able to assist in placing the kitten.

The Purchaser agrees that under no circumstance will this kitten be sold, leased or given to any pet shop or research lab.

Purchaser understands and agrees that if the kitten is placed in a new home other than that of the Purchaser, this contract and any replacement plan is NULL and VOID.

ADDITIONAL ITEMS:

The Purchaser understands and agrees that at the time of sale, the kitten is to be a pet quality animal. The purchaser may show the kitten on their own accord.

The Seller agrees to provide a TICA registration slip to the Purchaser. Registration and any associated costs are to be the responsibility of the Purchaser.

The Purchaser acknowledges that the Seller does not make any guarantees about personality, size, coat color, and/or coat pattern.

The Purchaser acknowledges that the Seller is not responsible for any allergies to kitten and that any type of allergies are not covered under this guarantee.

BREACH OF CONTRACT:

In the event the Purchaser is found to have violated any of the terms and conditions of this contract, the Seller may reclaim physical and legal ownership of cat with or without due process of law for any breach of contract with no refund of purchase price.

AGREEMENT:

By signing below, the Purchaser and Seller agree to all conditions set forth in this contract, and that no other warranty or guarantee, expressed or implied, is made under this contract except as stated herein..
